

End User License Agreement

This End-User License Agreement (this "Agreement") is a legal contract between you, as either an individual or a single business entity, and Crestwood Associates LLC ("Crestwood").

PLEASE READ THE TERMS AND CONDITIONS OF THIS AGREEMENT CAREFULLY BEFORE INSTALLING OR USING CRESTWOOD'S PROPRIETARY SOFTWARE (the "Software").

THE SOFTWARE IS COPYRIGHTED AND IT IS LICENSED TO YOU UNDER THIS AGREEMENT, NOT SOLD TO YOU. BY INSTALLING THE SOFTWARE. YOU ACKNOWLEDGE THAT YOU HAVE READ THIS AGREEMENT, THAT YOU UNDERSTAND IT, AND THAT YOU ACCEPT AND AGREE TO BE BOUND BY ITS TERMS. IF YOU ARE NOT WILLING TO BE BOUND BY THE TERMS OF THIS AGREEMENT, YOU SHOULD REFRAIN FROM ACCESSING OR USING THE SOFTWARE. THIS AGREEMENT REPRESENTS THE ENTIRE AGREEMENT BETWEEN YOU AND CRESTWOOD CONCERNING THE SOFTWARE, AND THIS AGREEMENT SUPERSEDES AND REPLACES ANY PRIOR PROPOSAL, REPRESENTATION, OR UNDERSTANDING YOU MAY HAVE HAD RELATED TO THE SOFTWARE.

1. License

1.1 Definitions.

- i. "Software" means Crestwood proprietary products for use by Licensee.
- ii. "Documentation" means any user and technical documentation for the Software in electronic or printed format that may be delivered to Licensee with the software.
- iii. "Licensee" means the end user of the Software.
- iv. "Perpetual License" means a license to use the software for an indefinite period of time with the option to purchase software maintenance on an annual basis (Annual Maintenance). Annual Maintenance is required with the first year of the Perpetual License purchase. Where Licensee is current on their Annual Maintenance fees, Licensee will be given access to the current product releases and any applicable software updates or fixes.
- v. "Subscription License" – means a license to use the software for a specified period of time, usually 1 year. Subscription Licenses include the software and software maintenance for the subscription time period. Where Licensee has paid their Subscription fees, and the Subscription period has not expired (or has been renewed), Licensee will be given access to the current product releases and any applicable software updates or fixes.

1.2. Grant of License. Crestwood hereby grants to you, and you accept, a limited, nonexclusive license to use the Software in machine-readable, object code form only, and any user manuals that may accompany the Software (the "Documentation"), only as authorized in this Agreement. For purposes of this Agreement, the "Software" includes any corrections and enhancements including hot fixes, patches, work-arounds, updates and upgrades to the Software ("Maintenance Releases") made available to end-users through Crestwood's (www.Crestwood.com) web site. Notwithstanding the foregoing, Crestwood shall be under no obligation to provide any Maintenance Releases.

1.3. Scope of Use. You may use (i) one copy of the Software on a single server (virtual or physical) owned, leased, or otherwise controlled by you, at a single time, and (ii) only on the type of data

base server licensed by you; provided, the database for the Software may reside on a separate single server. For purposes of this Agreement, "use" of the software means loading the Software into the temporary or permanent memory of a computer. You may use a reasonable number of copies of the Software for testing, off-line archival purposes, and training on a non-production server. No other right or license to use or make copies of the software is granted or implied.

1.4. Maintenance of Software.

- i. With a Perpetual License, Crestwood will make Maintenance Releases available to you if you have an active Crestwood Annual Maintenance plan and if and when such Maintenance Releases are made available to end-users of the Software.
- ii. With an active Subscription License, Crestwood will make Maintenance Releases available to you, if and when such Maintenance Releases are made available to end-users of the Software.
- iii. Maintenance Releases include Software updates, version upgrades and hot fixes, but do not include new products or add-ons to the Software which include new features for which Crestwood may charge a separate fee to its end-users.
- iv. All Maintenance Releases are subject to this Agreement. You acknowledge that installation of Maintenance Releases may cause customizations which have been made to your Software to no longer function as intended. To avoid such a situation, you should coordinate installation of all Maintenance Releases with the parties supporting your Software, test the Maintenance Release and any customizations on a separate test system, insure that the system is fully operational, and remedy any non-functioning components before installing the Maintenance Release on your production server.

1.4. Operating Environments. You acknowledge that Crestwood licenses the Software for use with (1) operating environments (web browsers, cloud services, servers, peripherals, database management systems and operating systems) supported by Crestwood, or (2) operating environments compatible with those supported by Crestwood. Crestwood makes NO representation as to what environments are compatible with supported operating environments.

1.5. Copies and Modifications. You may not reverse engineer, decompile, disassemble, or otherwise translate the Software or if applicable, any license keys you have obtained. You may not modify or adapt the Software or if applicable, any license keys that you have obtained in any way. Except as provided in Section 1.3 of this Agreement, you may make one copy of the Software, the Documentation, and any license keys that you have obtained, solely for backup or archival purposes. Any such copies of the Software, Documentation, or if applicable, license keys shall include any copyright or other proprietary notices that were included on such materials when you first received them

1.6. Assignment of Rights. You may not sublicense, lease, rent, or lend your rights in the Software, Documentation, or if applicable, license keys, as granted by this Agreement, with any third party without prior written consent of Crestwood. Notwithstanding the foregoing, you may assign your rights in this Agreement without such consent in the case of a sale of substantially all of your assets or equity interests, or in the case of a merger, change in control or similar transaction, provided that (i) the assignee agrees in writing to be bound by the terms and conditions of this Agreement, (ii) you are not in material default hereunder, and (iii) you agree to remain liable for any breach of this Agreement by the assignee.

2. Intellectual Property and Confidentiality

2.1. Use Reporting, License Violations and Remedies. Crestwood reserves the right to gather data on key usage including license key numbers, server IP addresses, domain counts and other information deemed relevant, to ensure that our products are being used in accordance with the terms of this Agreement. Crestwood expressly prohibits simultaneous, multiple installations of our licensed products without prior written approval. Any unauthorized use shall be considered by Crestwood to be a violation of this Agreement. Crestwood reserves the right to remedy violations immediately upon discovery, by giving written notice thereof to you and charging the then current list to become whole.

2.2. License Automatic Update and Expiration. Your license may include an expiration date that can result in the termination of the license. For perpetual (non-lease) the license does not expire unless Crestwood determines that a license is used in violation of the terms of this Agreement.

2.3. Proprietary Rights to Software and Trademarks. You acknowledge that the Software and the Documentation are proprietary to Crestwood, and the Software and Documentation are protected under United States copyright law and international treaties. You further acknowledge and agree that, as between you and Crestwood, Crestwood owns and shall continue to own all right, title, and interest in and to the Software and Documentation, including associated intellectual property rights under copyright, trade secret, patent, or trademark laws. This Agreement does not grant you any ownership interest in or to the Software or the Documentation, but only a limited right of use that is revocable in accordance with the terms of this Agreement. Any and all trademarks or service marks that Crestwood uses in connection with the Software or with services rendered by Crestwood are marks owned by Crestwood. This Agreement does not grant you any right, license, or interest in such marks, and you shall not assert any right, license, or interest in such marks or any words or designs that are confusingly similar to such marks.

2.4. Restrictions on Use of the Software. You shall permit only authorized users, who possess rightfully, to use the Software or to view the Documentation. Except as expressly authorized by this Agreement, you shall not make available the Software, Documentation, or if applicable, any license key to any third party. You will use your best efforts to cooperate with and assist Crestwood in identifying and preventing any unauthorized use, copying, or disclosure of the Software, Documentation, or any portion thereof.

3. Perpetual License or Subscription License Fees

Upon acceptance of this Agreement, you may obtain a license by paying the requisite perpetual license or subscription license fees, using the procedure set forth by Crestwood. The license fees paid by you are paid in consideration of the license granted under this Agreement. Crestwood does not refund perpetual license or subscription license fees. By accepting this Agreement, you fully understand that once the perpetual license or subscription license fee payment is made to Crestwood you will have no recourse for receiving a refund of any part of the fees.

4. Term and Termination

4.1. This Agreement is effective upon your acceptance of the Agreement, or upon your downloading, installing, accessing, and using the Software, even if you have not expressly accepted this Agreement. This Agreement shall continue in effect until terminated.

4.2. For a Subscription License, your license includes an expiration date that can result in the

termination of the license. Your subscription fees must be processed prior to the expiration date of your license in order for the license updates to be performed and the license to use the Software to be extended. Crestwood is not liable for any damages or costs incurred in connection with expiring licenses.

4.3. Without prejudice to any other rights, this Agreement will terminate automatically if you fail to comply with any of the limitations or other requirements described herein. If you are subscribing to the Software, and fail to pay the applicable subscription fees, Crestwood shall have the right to disable the Software. You may terminate this License Agreement at any time by: (i) providing written notice of your decision to terminate the Agreement to Crestwood, and (ii) either returning the Software, Documentation, all copies thereof, and all license keys that you have obtained to Crestwood or destroying all such materials and providing written verification of such destruction to Crestwood. However, perpetual license fees or subscription license fee payments made to Crestwood, by you, will not be refunded per section 3 of this Agreement. Crestwood may terminate this Agreement if you breach any term of the Agreement by giving you written notice of your breach and Crestwood's decision to terminate the Agreement. Upon termination of this Agreement by Crestwood, you agree to either return to Crestwood the Software, Documentation, all copies thereof, and all license keys, if applicable, that you have obtained, or to destroy all such materials and provide written verification of such destruction to Crestwood. If this Agreement is terminated, Crestwood reserves the right to refuse to license the Software to you in the future. Once the Software is disabled as a result of termination of this Agreement, Crestwood reserves the right to impose a charge for access to the disabled Software.

5. Remedies, Indemnification

5.1. Crestwood will, at its expense, indemnify and hold you harmless against any claims made by an unaffiliated third party that the Software infringes its patent, copyright or trademark or misappropriates its trade secret; provided (i) you notify Crestwood, in writing, not later than 20 days after you receive notice of the claim, (ii) you give Crestwood sole control of the defense and any settlement negotiations, and (iii) you cooperate with Crestwood in defending against or settling the claim. Crestwood's obligation of indemnification will not apply to the extent that the claim is based on (i) your use of the Software after Crestwood notifies you to discontinue use due to such a claim; (ii) your combining the Software with non-Crestwood product, data or business process including third party add-ons or programs; (iii) damages attributable to the value of the use of a non-Crestwood product, data or business process; (iv) your altering or modifying the Software, including any modifications by third parties; or (v) your use of the Software in violation of this Agreement. You will reimburse us for any costs or damages that result from these actions. If Crestwood receives information concerning an infringement or misappropriation claim related to the Software, Crestwood may, at its expense and without obligation to do so, either (i) procure for you the right to continue to run the Software or (ii) modify the Software or replace it with a functional equivalent, to make it non-infringing, in which case you will stop using the allegedly infringing Software immediately. If, as a result of an infringement or misappropriation claim, your use of the Software is enjoined by a court of competent jurisdiction, Crestwood will, at its option, either procure the right to continue its use, replace it with a functional equivalent, modify it to make it non-infringing, or refund the amount paid and terminate the license granted in this Agreement. This Section 5.1 constitutes your exclusive remedy for third party infringement and trade secret misappropriation claims.

5.2. You will, at your own expense, indemnify and hold Crestwood, and its subsidiaries and affiliates, and all officers, directors, and employees thereof, harmless from and against any and all claims, actions, liabilities, losses, damages, judgments, grants, costs, and expenses, including reasonable attorneys' fees (collectively, "Claims"), arising out of any use of the Software by you, any party related to you, or any party acting upon your authorization in a manner that is not expressly authorized by this Agreement.

6. Limited Warranties; Disclaimer

6.1. Limited Warranties. Crestwood warrants that, for a period of ninety (90) days from the date the Software is delivered to Licensee, the Software will substantially conform to the Documentation provided that it is properly used with the operating system for which it was designed. Crestwood warrants that it is the owner or authorized Licensee of the Software or has the rights to license the Software to Licensee under the terms of this Agreement. Crestwood warrants that the Software, as delivered by Crestwood, is free from any virus.

Crestwood does not warrant that the functions contained in the Software will meet Licensee's requirements or that the operation of the Software will be error-free or be uninterrupted. In order to receive and maintain the above warranties, Licensee must (i) use the Software in accordance with the Documentation; (ii) use the Software on the hardware and with the operating system for which it was designed and in accordance with operating requirements and procedures for such hardware and operating systems; and (iii) allow only personnel trained on the Software to operate the Software.

The above warranties are null and void if Licensee or any third party modifies or changes the Software in any way beyond the scope of the customization options contained in the Software, or otherwise than in accordance with the requirements or procedures for such customization, or if failure of the Software has resulted from accident, abuse or misapplication. The warranties do not apply to errors or malfunctions caused by (i) machine malfunction; (ii) equipment or software not licensed in this Agreement; (iii) use of procedures or data by Licensee not in accordance with the Documentation; or (iv) any other cause not attributable to Crestwood.

Licensee acknowledges that Crestwood is not required to maintain compatibility between the Software and any software not specified in this Agreement.

6.2. Duty to Inform. If Licensee believes that the Software is not substantially performing in accordance with the Documentation, Licensee will promptly notify Crestwood in writing regarding any such non-performance and will provide a listing of output and such other data as may be required by Crestwood to reproduce operating conditions as existed when the non-performance occurred.

6.3. Disclaimers. EXCEPT AS PROVIDED IN THIS SECTION 6, CRESTWOOD DISCLAIMS ANY AND ALL WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, TO THE EXTENT AUTHORIZED BY LAW. WITHOUT LIMITING THE FOREGOING, CRESTWOOD EXPRESSLY DISCLAIMS ANY WARRANTY THAT THE SOFTWARE WILL MEET YOUR REQUIREMENTS OR THAT OPERATION OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE. YOU ASSUME RESPONSIBILITY FOR

SELECTING THE SOFTWARE TO ACHIEVE YOUR INTENDED RESULTS, AND FOR THE RESULTS OBTAINED FROM YOUR USE OF THE SOFTWARE. YOU SHALL BEAR THE ENTIRE RISK AS TO THE QUALITY AND THE PERFORMANCE OF THE SOFTWARE.

7. Limitation of Liability

CRESTWOOD'S CUMULATIVE LIABILITY TO YOU OR ANY PARTY RELATED TO YOU FOR ANY LOSS OR DAMAGES RESULTING FROM ANY CLAIMS, DEMANDS, OR ACTIONS ARISING OUT OF OR RELATING TO THIS AGREEMENT, INCLUDING WITHOUT LIMITATION CRESTWOOD'S INTELLECTUAL PROPERTY INDEMNIFICATION OBLIGATIONS, SHALL BE LIMITED TO THE AMOUNT OF LICENSE FEES PAID TO CRESTWOOD BY YOU UNDER THIS AGREEMENT. THIS LIMITATION APPLIES TO ALL CAUSES OF ACTION OR CLAIMS IN THE AGGREGATE, INCLUDING, WITHOUT LIMITATION, BREACH OF CONTRACT, BREACH OF WARRANTY, INDEMNITY, NEGLIGENCE, STRICT LIABILITY, MISREPRESENTATION, AND OTHER TORTS. IN NO EVENT SHALL EITHER PARTY BE LIABLE TO THE OTHER OR ANY OTHER PARTY FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, EXEMPLARY, OR PUNITIVE DAMAGES OR LOST PROFITS, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

8. General Terms

8.1. Governing Law and Choice of Forum. This Agreement shall be governed by and interpreted in accordance with the laws of the State of Illinois, without regard to the conflicts of law rules thereof.

8.2. Severability. If any term or provision of this Agreement is declared void or unenforceable in a particular situation, by any judicial or administrative authority, this declaration shall not affect the validity of enforceability of the remaining terms and provisions hereof or the validity or enforceability of the offending term or provision in any other situation.

8.3. Survival. Articles 2, 5, 6, 7, and 8 of this Agreement and all Sections thereof, shall survive the termination of this Agreement, regardless of the cause for termination, and shall remain valid and binding indefinitely.

8.4. Headings. The Article and Section headings contained in this Agreement are incorporated for reference purposes only and shall not affect the meaning or interpretation of this Agreement.

8.5. No Waiver. The failure of either party to enforce any rights granted hereunder or to take action against the other party in the event of any breach hereunder shall not be deemed a waiver by that party as to subsequent enforcement of rights or subsequent actions in the event of future breaches.

8.6. Amendment. Crestwood reserves the right, in its sole discretion, to amend this Agreement from time to time. Crestwood will provide Licensee with the Updated Terms by either providing Licensee with written notice or by updating the Agreement on the Crestwood website (www.crestwood.com). You are responsible for regularly reviewing the terms and conditions of Crestwood's End User License Agreement. Your continued use of the Software 60 days after the most current version of Crestwood's End User License Agreement is posted at www.crestwood.com shall be conclusively deemed an acceptance of the amended Agreement.

8.7. Taxes. You shall, in addition to the Perpetual License or Subscription License fees required under this Agreement, pay all applicable sales, use, transfer, or other taxes and all duties, whether national, state, or local, however designated, that are levied or imposed by reason of the transaction contemplated under this Agreement, excluding income taxes on the net profits of Crestwood. You shall reimburse Crestwood for the amount of any such taxes or duties paid or incurred directly by Crestwood as a result of this transaction.

9. United States Government Restricted Rights

The Software and Documentation are provided with Restricted Rights. Use, duplication, or disclosure by the government is subject to restrictions as set forth in subparagraph (c)(f)(ii) of the Rights in Technical Data and Computer Software clause at DFARS 252.227-7013 or subparagraphs (b) (1) and (2) of the Commercial Computer Software-Restricted Rights at 48 C.F.R. S:52.227-19, as applicable.
